

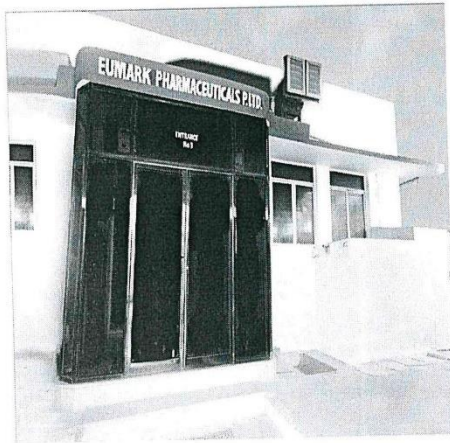

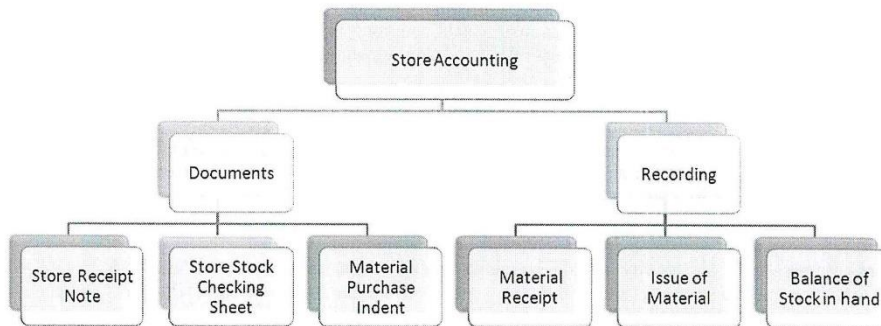

STORES



- **Procedure:** After receiving the material, the material is unloaded and cleaned by stores person. Material is transferred to designated quarantined area after physical verification. When the material is released by QC, QA affixes "APPROVED" label. Material is transferred to respective storage area.
- **Raw Material:** If storage limit is 2°C to 8°C, the material is transferred to cold storage. Rejected material is stored separately.
- **Packing Material:** Printed labels are kept in cupboards. Printed packing material is segregated and stored.
- **Dispensing of Raw Material:** Material requisition sheet is received from production. If the material is under test, QC is informed. Material is transferred to raw material dispensing area. Gowning procedure is followed while entering dispensing area. Stores person verifies all details like, material name, approved label, AR number, batch number, manufacturing and expiry date before dispensing. RLAF is put on 15 mins before dispensing. Cleanliness is checked. Calibration of balances is ensured. Different scoops for each material are used to prevent cross contamination. Sequence of material issued is: 1) Excipients 2) Active material 3) Colors & Flavors. "UNDER USE" label is put on last used container and quantity leftover is mentioned. RLAF is switched off and the room is cleaned. Empty containers are transferred to scrap.

MANUFACTURING

- **Entry and Exit Procedure:** Interlock system is present with 3 compartments . Footwear is removed. Ornaments are not carried inside. Hands are cleaned with liquid disinfectant solution (70% IPA). Gowning, slippers and gloves are worn which are kept in SS cupboard (no wooden).While exiting, gowning is removed. Entry to aseptic area is restricted.
- **Sterile Area Cleaning & Disinfection:** It is done to maintain bio-burden under control within acceptable limits. Dust and dirt is removed. Risk of cross contamination is minimized.
- **Health Personal Cleanliness and Behavior:** Footwear is changed. Hair must be fully contained. Cut resistant gloves are worn. Clothes are washed and sterilized. Any person suffering from ailment is not allowed in sterile area. Health check-up is done once a year.
- **Tray Washing:** Trays are washed with teepol solution (1% soap solution) and then with purified water.
- **Vial Deboxing:** Shipper of vials/ampoules is dedusted. Vials/ampoules are loaded.
- **Sterile Area Fumigation:** No activity should be taking place in the sterile area. Status label "AREA UNDER FUMIGATION" is put up. Areas cleaned. Heating, ventilation and air-condition unit (HVAC) is switched off. Fumigation is performed. Area is kept undisturbed for 7 hours.
- HVAC is switched on. It is performed on daily basis.
- **Line Clearance:** Ensuring if gowning procedure is followed , status board is displayed, vessels are cleaned, manufacturing area is cleaned, HVAC system is functional, raw materials are taken to manufacturing area, filling area is cleaned, cartonator machine is cleaned, packing area is cleaned.
- **Cleaning of LAF Prefilters:** Done monthly.
- **Manufacturing Area Cleaning:** Movable parts are dismantled. Immovable installations are cleaned in place. Clean and dried parts are assembled. Cleaned equipment should be used within 72 hours of date of cleaning. For cleaning accessories, they are transferred to respective cleaning areas. They are washed with potable water and teepol solution. They are rinsed with purified water. Accessories are wrapped and stored.
- **Stirrer Cleaning:** Shaft and propeller of stirrer are dismantled. Shaft, sides and base of propeller are cleaned with potable water and teepol solution at least twice till residue is washed off. It is rinsed with purified water and wiped with IPA. It is re-cleaned if not used within 72 hours.
- **Filling Assembly Dismantling & Cleaning:** Syringe and silicon tubing are removed from machine. Nozzle, valve, piston and silicon tubing of syringe are dismantled. Nozzle, valve, piston and silicon tubing are flushed with distilled water. Machine parts are autoclaved at 121°C for 30 mins.
- **Vial Washing Machine (make: AMBICA):** Line clearance of the machine is checked, for any broken leftover glass vials, if machine is properly assembled, if water lines are clear, spray nozzles, availability of water. LAF is switched 30 mins before. All motors and conveyors are started. Machine is started and level of water is checked. Vials are loaded on infeed conveyor. If the movement of vials and sprays are found okay, washing is started. 25 vials are sent to QA department for checking of particulate matter. Washing is continued after approval. 1 breakage.



MICROBIOLOGY DEPARTMENT

- **Viable Air Monitoring:** Microbial environment conditions are monitored by settle plate or air sampling method. Media plates are prepared aseptically. For monitoring, the plates are carried to the area to be monitored. Plates are marked with date and location. At the sampling location, the lid of the plate is removed and the plate is placed. After completion of sampling, the plate is covered with the lid. Plates are carried to microbiology laboratory and incubated for 5 days. Number of colonies are counted.
- **Preparation of Media:** Formulated commercially available dehydrated culture media is used. Direction to use is read, the container is checked for expiry date. Required quantity is weighed and transferred to a clean container. Purified water is added to dissolve it completely. The medium is boiled if required. The media is tested for pH. The pH is adjusted with
 - 0.1N Hydrochloric acid or 0.1N Sodium hydroxide. Media is sterilized in an autoclave. The medium is dispensed in required container. The dehydrated container is not left open for too long. Overheating and repeated heating is avoided.
- **Hot-air Oven:** Material is loaded in the oven. Power is switched on.
- Temperature is adjusted. It is switched off after completion of sterilization. The equipment can cool if the temperature is high. Oven and trays are cleaned with a lint free cloth dipped in a disinfectant solution.
- Calibration is done every six months..
- **Temperature Monitoring:** Temperature of equipment is monitored twice a day. Calibrated thermometer is used. Thermometer is placed in the center of the equipment and temperature is recorded after 2 mins.
- **General Safety:** Every individual wear clean laboratory garments in the laboratory and goggles and face mask while handling chemicals and microbial cultures. LAF bench space is cleaned with a disinfectant. Sources of contamination are kept away. It is not allowed to drink or eat in the laboratory. Accidents are reported. Disinfectant is poured on spillage and is kept in contact for at least 10 mins. No one can walk on spillage. Goggles, gloves and nose mask are worn while cleaning. Spillage is collected in discard bin. The laboratory is vacated if any abnormal smell is detected.
- **Cleaning of Glassware:** Remaining material is disposed off. Stains or pen markings are removed by wiping with acetone and scrubbing it off with scrubber and cleaning with tap water. For cleaning stubborn stains, the glassware is rinsed with dilute nitric acid and tap water. The glassware is dipped in 70% IPA for 30 mins. All glassware is rinsed with tap water. Glassware is dried in hot air oven.
- **Disinfection of Laboratory:** Entry lock, general corridor, sterilization area, media preparation area, washing area, incubator room glassware storage room, change room are cleaned and disinfected twice a day. Lint free mopping duster is used to remove dust from all surfaces of doors, window glass, wall incubator surfaces, grills, external surfaces of equipment. The floor is swept to remove dust using non-shedding lint-free dry mop. Mopping is done with purified water and dilute disinfectant. Media preparation table is cleaned and sanitized with 70% IPA solution.

QUALITY ASSURANCE

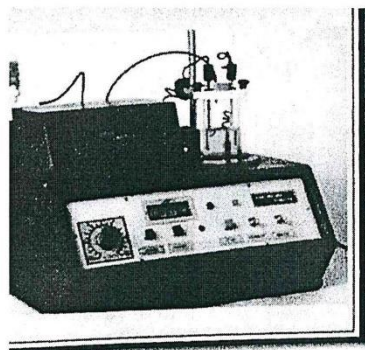
- **Market Complaint:** Product complaints are forwarded to QA department. Complaints received from drug regulatory authorities are evaluated as per directives received from them. Register contains details given below: Sr. No., Date of receipt, Complaint reference, Complainant, Details of complainant, Nature of complaint, Corrective action, Preventive action, Remarks. Any verbal complaint is formalized and investigated. Investigation is started after logging of complaint. If the complaint is critical, the marketing department is intimated for stoppage of further sale and distribution. The complaint is recorded as either
 - Critical, Major or Minor. In case of quality complaint, a complaint sample
 - is sent to quality control department for analysis. A reply is prepared based on complete investigation. Recalling of the batch depends on the nature of complaint. Feedback from complainant is taken.
- **Qualification of Vendors:** New vendors should be qualified and approved. Purchase department locates new vendors. A New Source Request Form is sent to QA Head for evaluation. There are 3 types of sources: New material from new source, Existing material from new source and New material from Existing source. The samples are analyzed by QC. QA Head recommends audit of supplier premises. Samples of printed packaging materials are submitted to QA department. If a lot does not comply to the specifications then the vendor shall be disqualified.
- **Master Formula Record (MFR):** Divided into 2 parts: Manufacturing part and Packaging part. First page has following details: Name, address and logo of company, Dosage form, Brand name, Generic name, Product code, Label name, Product description, Batch size, Pack size, Shelf life, Storage conditions, Drug schedule.
- **Self-inspection unit:** Audit is carried out at two levels: Self-inspection and Internal audit. Audit is carried out by QA Head in all departments. Audit is carried out as per the schedule prepared by QA department. Audit is distributed in triplicates. Audit may be conducted before submission of any regulatory body. 7-character number: AAXXNY, AA:
 - type of audit (SI: Self inspection, IA: Internal audit), XX: serial number of audit, YY: Year of audit. Classification: Critical, Major, Minor and Good Practice.
- **Training Program:** Every employee is trained on area of operation prior to start the work. Training calendar is prepared. Concerned department head confirms the date of training to QA Head. Training records are submitted to QA Department. 2 categories: Internal training and External training.
- **Line Clearance:** Equipment and area is cleaned. "CLEANED" label is affixed on cleaned equipment. Area status board is filled. Checkpoints are verified. Temperature, relative humidity and differential pressure must be within limits. If all points are satisfactory "CLEANED" label is signed. Absence of batch documents, labels, materials, powder, liquid or any remnants of previous products or batch and traces of water surrounding the equipment is ensured. If it complies " " is marked, if not "x" is marked. Proofs are verified by IPQA and it gives final line clearance to start the batch only after getting result from quality control department. Area status board includes clean status of floor, ceiling, walls, light fixtures, dustbins and surrounding areas. Overprinting stereotypes of previous batch or product are destroyed.
- **Medical Check-up:** All employees are examined by qualified physician.
 - A person undergoes medical check-up prior to employment. Check-up includes eye examination, color blindness, tuberculosis, skin and other communicable contagious diseases. If found unfit, the person is not recruited. Medical check-up is done once in a year. In case a person is found affected by a contagious disease, that person is not allowed to work and is advised for further treatment.
- **Validation of Autoclave:** Done twice a year.
- **Deviation Control:** Anything which works against a written procedure like Standard Operating Procedure, Standard Test Procedure, BMR, etc. is called a deviation. Critical deviation will have a significant impact on critical attributes of a product like manufacturing instructions are not followed, wrong batch details are printed, SOP not followed. Major deviation may have a significant impact on critical attributes of a product.

- **Documents:** The quality manual contains a statement of company's Quality Policy and Quality Objectives. Master documents are detailed documents for implementation of quality management system covering activities that influence the quality of the product. Records are categorized as: Primary records, Secondary records and Sundry records. All documents are made considering statutory requirements. All documents have a unique document number. Hand written documents are not considered as master documents. All master copies are kept with QA Department. Every document has sign & date of review. Red colored "MASTER COPY" stamp is used. All data maintained in software is password protected. Back up data is maintained. Changes during review are accessed by QA. Final printout is taken by QA. Pharmacopeias, books, reference guidelines etc. are issued, retrieved and controlled by QA. Issuance records are maintained.
- **Disposal of Expired Finished Goods:** Intimation is given by Stores
- Department for expiry of finished goods. Stocks are transferred to rejected area. Destruction note is prepared. Destruction is carried out in presence of Stores and QA Department.
- **Control Sample:** Control sample is collected from each batch of finished
- goods and raw material. The quantity of retention sample for finished goods and raw materials is twice the quantity required for carrying out complete analysis. Entry of control sample collected is made in BMR. The sample is stamped as "CONTROL SAMPLE". Control samples are stored in alphabetical order.
- **Change Control:** Any changes are proposed through "CHANGE CONTROL FORM". It is categorized as Critical, Major or Minor.
- Documents and data are submitted along with the form. Requirements for change control are evaluated by QA. A unique number is allocated to change control. A new series of change control number starts at the beginning of new calendar year. After receiving comments from relevant departments, the change control is approved or rejected by QA. After approval, a change intimation is sent. Implementation of change control is evaluated by QA personnel.
- **Handling of Spillage:** On spillage, all persons are informed to take care
- and the worker to clean the spillage.
- **Dispatch of Finished Goods:** After completion of packing, an intimation is given by packing department. Under test finished goods are stored in quarantine area. Goods are dispatched as per indent received.
- **Artwork of Packaging Material:** MOH approved packaging development module and pdf files are received from Regulatory Affairs Department. Packaging department is responsible for designing the

- **Product Recall:** Any written complainant received is investigated. QA head decides for product recall. Product recall is either Voluntary or Forced. Form is forwarded to QA head for approval. Distribution record is checked. QA Head advises Distribution Head to instruct distributors to stop sale of product. Follow-up is monitored. Necessary arrangements are made to receive recalled product. Recalled stock is destroyed as per destruction procedure. Local drug authority is informed about the recall. Mock recalls are also conducted. Mock recall identifies potential problems. Corrective actions are documented in recall report.
- **Corrective and Preventive Action:** Corrective action is an action taken to rectify a specific deviation. Source document provides corrective and preventive actions. CAPA form is treated as tracking form. CAPA form is issued by QA. QA verifies the implementation and completion of CAPA.
- **Site Master File:** Site master file contains 25 to 30 A4 size papers. Site plan, outline drawing, schematic layouts, pressure segregation are attached. Each page has a header and footer. Site master file is prepared by, reviewed by and approved by QA head. Amendments are made on approval of QA Head. It includes licensed manufacturing activities, short description of site, use of assistance in manufacture and analysis, organization chart, organogram, health requirements of personnel, hygiene requirements, nature of construction, brief description of ventilation system, description of planned preventive maintenance programs, sanitation procedure, preparation, revision and distribution of documents, description of production operations, handling of rejected material and product, quality control system, product recalls, and self-inspection programs.
- **Good Documentation Practices:** All entries are made with blue ball pen in clear and legible handwriting. Use of ink pen, gel pen, white ink, blade, eraser and pencils is avoided. Short terms are avoided. Data is recorded
- online too. Correct data is written next to incorrect data along with initials. Overwriting is prohibited. Supplements attached are signed with date. Empty fields are invalidated by crossing them out. Time entry is written in the form of 24:00 hrs.
- **Batch Manufacturing Record:** It is the written document of the batch that is prepared during manufacturing process. It contains step-by-step details of manufacturing process. Every batch has a separate BMR. First page of BMR has records about the batch. Safety instructions to be followed during manufacturing process are written. Checklist of cleaning of all equipment is prepared. List of raw materials with quantity and AR number is mentioned. Yield of the batch is calculated. List of abbreviations are made.

QUALITY CONTROL

- **Analytical Balance :** Weighing pan is placed on balance. AC adapter is connected to the specified power supply and the AC adapter's other terminal is plugged into the socket in the back of the balance. After the main power supply is switched on, the "On/Off" key is touched. A container or butter paper is placed on the weighing pan. "Tare" key is pressed. Sample to be weighed is placed up-to the desired weight. Stability detector symbol "O" is seen when stability is achieved. To switch off the balance, "On/Off" key is touched till the display disappears. Balance is protected from vibrations, thermal fluctuations, sunlight, moisture & air currents. Balance is calibrated daily with standard weights.
- **Karl-Fisher Instrument:** For burette calibration, burette outlet is placed in 10ml calibrated measuring cylinder. The obtained volume and displayed volume is recorded. For instrument performance, 100 mg of disodium tartrate is added into titration vessel containing neutralized methanol and tested for water content. % water(W/W) is calculated using the formula,
$$\% \text{water} = \frac{\text{Volume of KFR consumed in ml} \times 100 \times \text{Factor}}{\text{Weight of disodium tartrate}}$$
- 150 ml of Karl-Fisher reagent is taken. Glassware is well dried or otherwise the reagent becomes useless due to moisture. KFR is put in the reservoir bottle at the back and stopper is placed immediately. Methanol is added in the moisture beaker to such an extent that the metal wires of the sensor are fully immersed. Dispensing burette is put on top of KFR bottle. "Start" key is pressed. "Smpl" is pressed and sample taken for analysis is added.

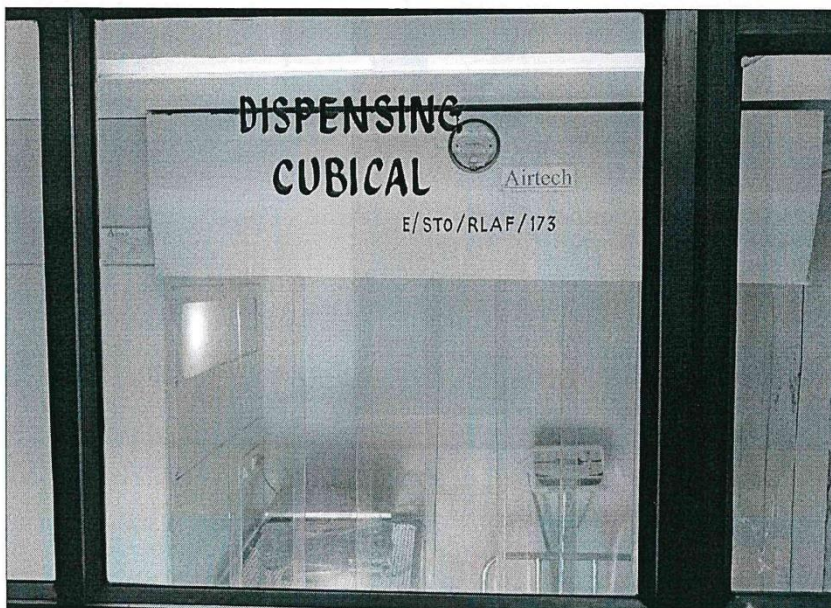
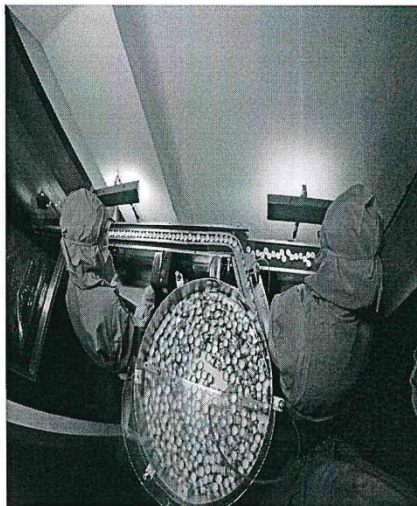
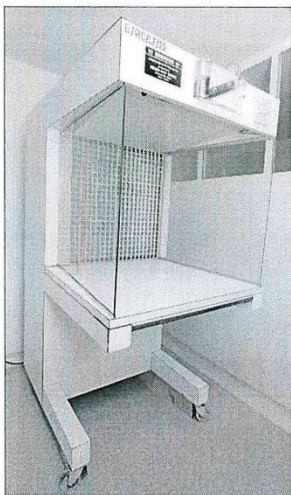


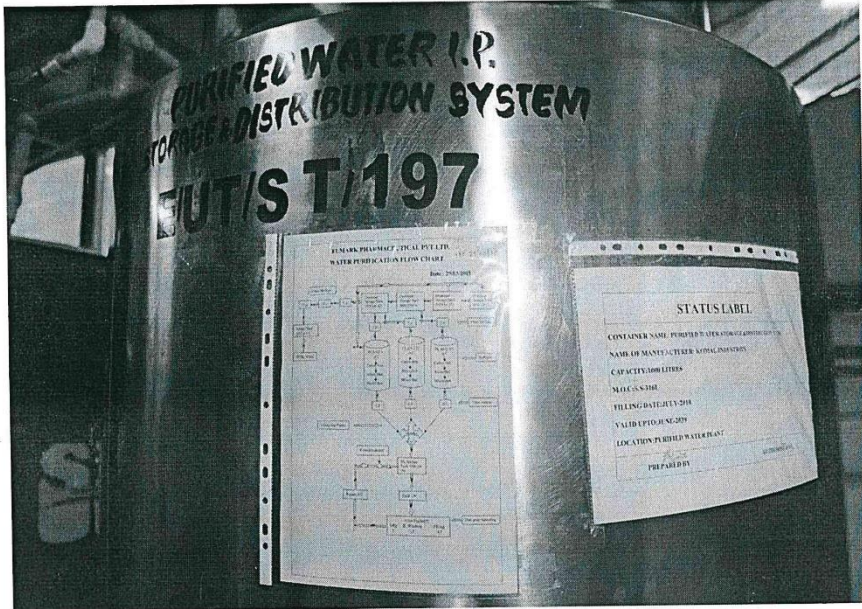
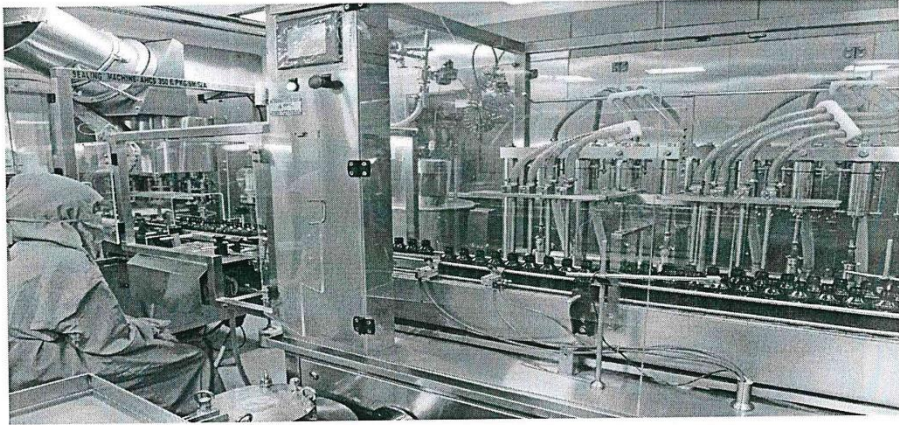

- Washing of Glassware:** For cleaning of glassware that are used for chemical analysis special precautions are taken to avoid any chemical residue on glassware, which may later interfere with chemical analysis.

Cleaning of glassware which has contained hazardous material is undertaken by experienced personnel. New glassware is soaked in acid water before washing. Glassware is washed quickly after use. For better results, hot water is used. All parts are thoroughly scrubbed with brush, but abrasion is avoided. Special types of precipitates are removed using nitric acid, aqua regia or fuming sulfuric acid. Labelling of marker pen is removed with the help of IPA or acetone. After cleaning, the glassware is dried in hot air oven. Pipette tip is placed down in a cylinder containing detergent solution. Burettes are washed with detergent water. Burettes are always covered when not in use.
- Sampling of Water:** Dry conical flask is plugged with cotton. Flask is taken to sampling area. Water is collected through tap for 30 seconds. Flask is rinsed with this water. 500 ml of water sample is collected in the flask. Flask is labelled. Sampling points of purified water in production area are marked with yellow color. Results of the test are recorded. In case any test fails, the maintenance department is informed. Water is sampled every day. Sampling points of raw water in production area are marked green.
