It is, however, made clear that this approval is granted on the basis of the documents and the information supplied by your college. In case the information so given is found incorrect and/or in case, any illegality or irregularity caused in granting such admissions is brought to notice of the Authority at later point of time, it will be open for the Authority to take appropriate action in that regard. Further, the Authority directs that the college shall charge fees as decided by the Fees Regulating Authority and in case, any excess fees is found to be charged by your College/ Institute; it shall be refunded to the concerned, forthwith.

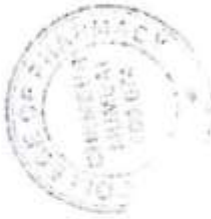
