#### Reporting for Counseling:

Candidate / Parent has to be present for counseling of admission as per notified schedule along with all the Original Documents and Total Fees payable. If candidate is absent for the counseling, he/she forfeits his/her claim on the seat and the seat will be offered to the next candidate in the merit. If any such candidates report at a later stage, he/she will be considered only if seats are remaining vacant after completion of the respective admission round.

#### Payment of Fees:

Candidate has to arrange for full fees payable by preferred mode of payment mentioned at “Admission Against CAP vacancies” section at <https://vespharmacy.ves.ac.in/> at the time of confirmation of admission. The candidate can opt for optional modes of payments, however candidate will lose claim on allotted seat in case of non-payment of full fees for any reason. Admission will be given as per inter-se-merit.

**Note:** The preference shall be given to the Maharashtra State Candidature Candidate over All India Candidature Candidate on the basis of Inter-Se-Merit as per clause (i) rule 13 of the Information Brochure published by State CET Cell, Maharashtra State for admission to “Full Time Professional Under Graduate Technical Courses”, “Full Time Professional Post Graduate Technical Courses”.

Candidate's candidature type displayed in the Final Merit List published by State CET Cell, Maharashtra State will be considered as a final candidature for the display of institutes level Merit List for against CAP admission. Any change in the candidature type shall be communicated to the college by candidate before 16.12.2024.
